2. Certificate

Successful trainees (minimum 60% pass mark) will get an **ICCE International Certified Certificate.** After-training test is mandatory.

3. Timeline

Registration is open from July 13th 2022 until August 12th 2022. Trainees will be notified on dates of a specific training scheduled between September and December 2022.

Each course will last 60 hours and training period will be evenings and weekends.

4. Training fee per course

- Application fee: free
- Training fee: 250,000 Rwf per course per individual
- For Institutions with more than 10 participants the training fees is 200 000 RWF per person
- EPRN members: 200,000 Rwf per course
